There will be designated locations for **everyone**, therefore anyone parking their concessions prior to coming to the office, may be asked to move. Anyone using more space than requested on contract will be charged an additional fee which will be twice the current rate per square foot.

**ERIN RODEO 2008
RENTAL AGREEMENT
RULES AND REGULATIONS**

1. If for any reason it is necessary to cancel this Agreement, the Erin Rodeo 2008 must be notified 15 days prior to the opening day of the event or there will be no refund. ***There will be a 20% cancellation fee deducted from your refund for administrative costs.***
2. **One standard 15 amp. 110 v. outlet will be available at the listed cost.**
3. Public address systems at concessions, selling of raffle tickets on the Fair Grounds, or subletting of space, is not permitted without the written permission of the Erin Rodeo 2008 prior to May 1st.
4. The Committee reserves the right to limit the number of admission passes to Concessionaires. Two bracelets will be provided per concession.
5. The Committee will take all reasonable precautions to ensure the safety of displays, which are placed at owner's risk.
6. Concessionaire will be liable for, and will indemnify and hold harmless the Erin Rodeo 2008 from any loss or damages whatsoever suffered as a result of any loss or damages by theft, rain or whatsoever occurring to, or suffered by, any person or company, including, without limiting the generality of the foregoing, Concessionaires, the Committee, the owner of the building and their respective agents, servants, employees and members of the public attending the event, either (a) on the said space or (b) elsewhere if said loss or damages arose from or were in any way connected with Concessionaires occupancy of space. **PROOF OF INSURANCE IS REQUIRED.**
7. **The following items will NOT be allowed to be sold: knives of any type, laser pointers/lights, exploding bags, cap guns, drug related items, illegal items or any item that may be of a safety concern. The Erin Rodeo Committee has the right to ask for items to be removed from concession space.**
8. Should any question arise not provided for in the rules and regulations of the agreement, the decision of the Erin Rodeo 2008 shall be final.
9. Concessionaires will be required to make use of all recycling bins provided by the Erin Rodeo 2008 (glass and cans).
10. **All concessions must be on site by Friday, June 6th, 2008 by 3 pm but must not arrive before designated times as per contract** unless otherwise arranged with Erin Rodeo contact.
11. When booking square footage for outside concessions, please allow enough room for all open canopies, free standing displays and trailer hitches. **Vehicles will be asked to park elsewhere. If they are not parked where designated, they will be towed.**
12. Your space will be guaranteed upon receiving the signed agreement and full payment for the concession space.
